WARD D CLOSING CAUSES DISSENSION

The 20 beds on Psychiatric Ward D are now history. The Health Department's plan for the closure was given the stamp of approval by the Board of Supervisors November 14. The public was told that the cut would not leave Contra Costa's Mental Health System short of acute beds.

Not all of those working in the system agree. Later that day there was a meeting at the hospital that became so heated, the Director of Psychiatry said he would have to leave the meeting.

CLUBHOUSE REPORT

The 9th Western Regional Clubhouse Conference By Mae Bragen

On September 14, 2006, Lee Cowden and I traveled to the beautiful resort town of Park City, Utah to attend the Western Regional Clubhouse Conference. This conference takes place in one of the western states every other year. (Lee was one of the first presidents of our NAMI chapter.)

Nestled in the mountains of Utah it snowed the whole time we were there. It was lovely, but cold. The theme was "The Light To Recovery" and indeed, what I discovered from the hundreds of consumers (members of clubhouses) who attended the conference, was their enthusiastic sense of being active participants in the lives of their communities.

All of the workshops dealt with the work orientation of the clubhouse model of rehabilitation including discussions of the work units that keep the clubhouses running: team building, stress management, healthy lifestyles, leadership, developing recreational and social programs, fund raising, and transitional employment, supported education and many other topics.

My first observation was the lively socializing that was going on constantly among clubhouse members. There were no "wallflowers". There were a lot of close friendships that had formed among them.

Each clubhouse had their own banner which they proudly displayed on the walls of the main dining/conference hall and later

displayed during a ceremony. Slides and videos were shown on a continuous basis. One table was devoted to tech support.

Several plenary sessions featured such people as the Mayor of Park City, a TV news anchor, faculty of the International Center for Clubhouse Development (ICCD), an Olympic Gold Medalist, an Executive Director of the local Mental Health Department, The Director of the State Dept. of Substance Abuse and Mental Health, a Manager at a Law Firm and a Manager of a hotel both of whom had placed members in transitional employment positions.

The workshops were all geared to those of us in various stages of training regarding the clubhouse model. The ones I attended were entitled; "Clubhouses Succeed If There Is Meaningful Work ", "If You Build It, They Will Come", "Developing Jobs That Are Right For Your Members".

The conference was by no means all work and no play. Besides walking around in the snow and exploring Park City, there was a wonderful tour of Olympic Park and the "Flying Aces" ski jumpers, a Gala Banquet and Dance and entertainment by Polynesian dancers.

In two years the conference will be held in Hawaii. It would be great if many of us could go and tell all that our clubhouse is up and running. For more options, visit this group at:

contested election in the history of the county.

Mark has had a long time interest in the welfare and needs of children along with the challenges of the mental health system. He helped lead the way to the passage of Proposition 63, which has already brought several million dollars to the county.

In June 2001, Supervisor DeSalunier, recognizing the great need for women's health services, introduced a comprehensive Women's Health Program that serves the health care needs of all women in Contra Costa County.

He brought the principles of performance based budgeting to the county. This requires each department to submit extensive Annual Performance Reports as part of the budget deliberations.

As a long time restaurant owner (TR's Bar and Grill in Concord), he is familiar with the needs of local businesses. He established the Business Leaders' Alliance to create a partnership between government and the private sector.

Mark DeSaulnier was born in Lowell, Massachusetts and received his Bachelor of Arts degree in History from the College of the Holy Cross. An avid runner, he has completed twenty-one marathons. He makes his home in Concord where he raised his two sons, Tristan and Tucker.

DeSaulnier will be sworn in as a member of the California State Assembly, December 4, 2006. Susan Bonilla, Mayor of Concord has been elected to Mark's office.

The sharp difference of agreement is over the best way to respond to the loss of an estimated \$2 million to \$2.8 million in federal payments. The loss would occur because of the inadequate qualifications of the management of the unit. The Psychiatric Emergency Unit (PSE) budget has been about \$4.5 million annually.

The Fed's insist that the director of inpatient psychiatric services and the nursing director do not have the proper credentials.

The Emergency unit is located on the third floor of the hospital. The remaining Psych Ward C is on the fourth floor.

The Emergency unit is where people who have been 5150'ed (taken against their will) are taken to be evaluated. People also seek the services of the unit voluntarily.

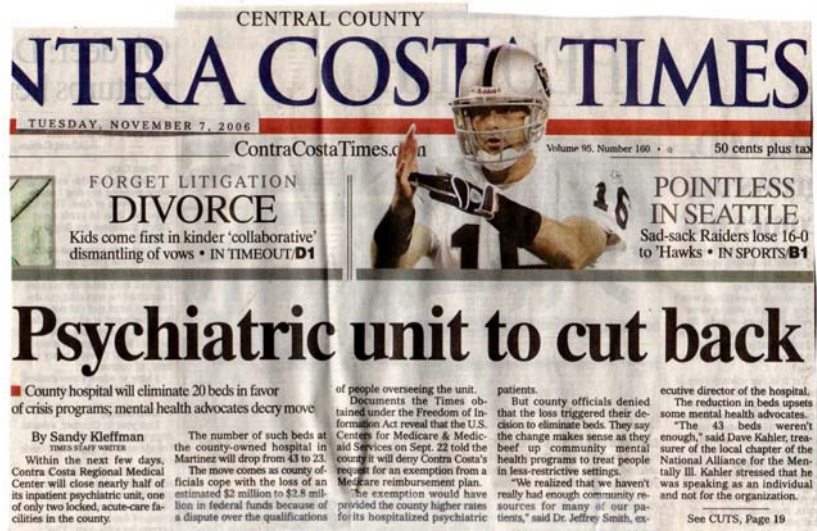
The federal agency mandates that the director of inpatient psychiatric services must be a psychiatrist. Miles Kramer who currently holds that job is a licensed clinical social worker.

NAMI-CC has had considerable experience with Kramer and found him to be an outstanding administrator.

Inpatient vs. Outpatient

The crux of the argument is whether the newly created outpatient program has been created to cover the loss of Ward D or is this the dawning of a new age in treatment.

The main argument in favor of closing Ward D is that the census has dropped to an average of 31. It would be very costly to pay for the staffing for the 12 (Continued on page 6, column 3)

Clinical Depression**STUDY
CONFIRMS
SEROQUEL
EFFICACY**

ALDERLEY PARK, MACCLESFIELD -- November 17, 2006 -- Results from the newly published BOLDER II (Bipolar Depression) study confirm that Seroquel® (quetiapine fumarate) has the potential as a single medication to treat for major depressive episodes in patients with bipolar disorder.

The results, published in the December issue of the *Journal of Clinical Psychopharmacology*, reinforce the positive findings of the landmark BOLDER I study, and have led the FDA to approve Seroquel for the treatment of depressive episodes associated with bipolar disorder for patients in the US. BOLDER II, an 8-week, multicentre, placebo-controlled trial, found that patients treated with Seroquel 300 mg or 600 mg per day had significant improvements in their depression compared with those placebo recipients.

"Patients treated with Seroquel in BOLDER II saw an improvement in their depressive symptoms within one week and more than half by week eight," said Professor Michael Thase, Medical Director, University of Pittsburgh Medical Center, Pittsburgh, Pennsylvania, and the study's principal investigator.

As a result of the positive findings from the two BOLDER studies, Seroquel is now the first and only single medication approved by the FDA to treat both the depressive and manic episodes associated with bipolar disorder. "I think this is good news for patients with bipolar disorder, because we know that it's much more difficult

to treat depressive episodes than manic episodes," said Professor Thase. "Depressive episodes are far more debilitating for patients and can last three times longer than manic episodes. Now both can be controlled with a single daily treatment that should be easy for patients to use."

Approximately 3–4% of adults worldwide are affected by bipolar disorder, a serious psychiatric condition which was previously known as manic depressive illness. Bipolar disorder is characterized by recurrent episodes of mania and, more commonly, depression. The disease is chronic and can create considerable problems for patients, spouses and family members if left untreated.

Ongoing Seroquel SR™ clinical studies also cover major depressive disorder and generalized anxiety disorder. Seroquel is the number 1 prescribed atypical antipsychotic in the United States. With a well-established safety and efficacy profile, Seroquel has had more than 19 million patient exposures worldwide since its launch in 1997. unused beds. There is some disagreement over whether there has been a change in the criteria for admitting persons to the psychiatric ward. There are reports from the families and the mental health staff about persons that seem to be in real need of *acute hospital* care that are not admitted.

"I was very surprised there was not more protest over the closure of Ward D."

Sandy Kleffman, the reporter who has written the series for the Contra Costa Times on changes at the hospital.

Just one person spoke against the closure, Nancy Thomas of Danville. The issue was scheduled late in the Board meetings day when most of the audience had left.

Members of the staff that NAMI talked with emphasized that there is no substitute for an acute bed in a locked facility when the need is there. Contra Costa County now has a population in excess of one million and just 23 acute psychiatric beds.

The county is planning to set up outpatient teams to help those patients discharged from the hospital. Ward D is gone and these teams are in the process of being planned and implemented. Similar to emptying the State hospitals and not providing any local facilities for the patients.

THREATENED CLOSURE

FED'S LODGE COMPLAINT

Contra Costa Regional Medical Center Accused of Dumping Patients

The County Hospital could lose \$300 million in federal payments if some complaints are not successfully responded to. It would close the hospital, according to Dr. Jeffery Smith, the hospital's executive director.

The complaints were based on what they termed were the improper transferring of three psychiatric patients. According to a November 17, 2006, article in the Times by Sandy Kleffman, it is often referred to as "patient dumping."

Dr. Smith submitted a correction plan to the federal agency and says he does not anticipate any difficulty in clearing the matter up.

Other staff members said it was highly unlikely that the hospital would not be able to satisfy the federal agencies complaints.
