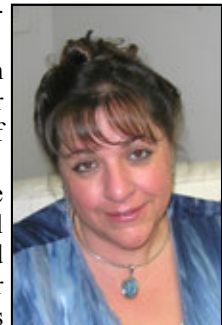

Working with Marti Wilson, Forensic Community Liaison, the grant was secured from the state Corrections Standards Authority under the MIOCR program (Mentally Ill Offender Crimes Reduction).

O'Malley told the audience that the Mental Health Court would begin later this spring by processing some cases and increasing that number as the court works out the start-up flaws.

She said the accused that would be processed through the court would be there on a voluntary basis.

The 200 plus mental health or behavioral health courts that have been operating around the country were discussed. Most of these Mental Health Courts have resulted in significant reductions in the incarcerations and the durations of the prisoners' stay.

COLETTE O'KEEFFE RECEIVES SCHOLARSHIP

NAMI-CC proudly presented Dr. Colette O'Keeffe a scholarship for her unflinching determination to continue striving toward her goals in psychiatry. Ultimately, she plans to work in public sector medicine, such as county mental health, possibly specializing in pediatric psychiatry.

The NAMI-CC Board considers Dr. O'Keeffe a superior scholarship recipient for placement in a psychiatric intern program for a multitude of reasons. First, Dr. O'Keeffe, who has struggled with bipolar disorder for the greater part of her life, comes from academic and medical bases, having earned a BA in physics from Harvard and having practiced anesthesiology for years.

Her current work in Contra Costa Mental Health, her advocacy for patients' rights (including instituting a support education program), and her activism with NAMI are significant. Additionally, she has fortitude, a willingness to press on despite major setbacks, the most recent of which was an eye illness which forced her to forego a psychiatry residency and start anew. Dr. O'Keeffe is already a proven asset to the community and a powerful role model. She has been the ideal role model.

NAMI-CC is grateful to Dr. O'Keeffe and supports her ongoing efforts.

A quote from Dr. O'Keeffe: "Appropriate medications, help from NAMI, and being loved by two elderly, eccentric cats have helped in my recovery.

HOSPITAL'S PROBLEMS CONTINUE

STATE AGENCY EXPECTED BACK IN FEBRUARY

Dr. Scott Weigold wrote an article which appeared in the September NAMI-CC newsletter in which a box was placed in its center with a quotation from him. It is reprinted below. It was obviously prophetic. (You can read the whole article on the NAMI website.)

Our performance has been a regulatory time bomb, and now *we are standing at ground zero.*

We are dealing with the debris from that "time bomb" which went off when the U.S. Centers for Medicare and Medicaid sent the county the 114 page document which laid out the problems they found at the hospital in September, 2006. In it 52 "deficiencies" were listed.

The hospital's administrators were given until March 15, 2007 to make the corrections. Failure to do so could result in cuts of as much as \$300 million which would close the hospital.

Investigators will return to the hospital sometime in February to evaluate the effort to make the corrections.

Since the closing of Ward D and its 20 acute care beds (46%), the remaining beds have been pushed to capacity creating major problems according to its staff.

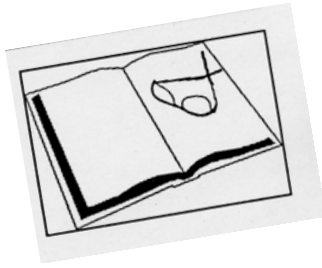

BOOK REVIEW



The Dream and The Nightmare, by Myron Magnet, Encounter Books, San Francisco, CA, 269 pages, \$22.50.

This excellent book chronicles the debacle of the emptying of the state mental hospitals with the promise of psychiatric clinics across the land. A promise that was never kept and explains many of the problems we face today. About half of those planned actually opened, the first one in 1967. Only 789 centers of the 2000 planned actually went on to serve the mentally ill.

One of the driving forces to empty the state hospitals was that the new programs, Medicare and Medicaid paid only for those patients *not* in those hospitals.

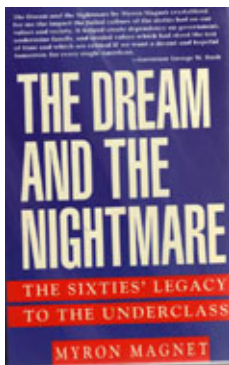
Under the banner of saving money they nearly emptied the hospitals but found they had great difficulty cutting the staffs. "Cutting the patient population 66 percent between 1969 and 1981, most state hospitals balked at firing staff, whose salaries ate up three quarters of the budgets of those institutions."

The author points out that "the total amounts spent on

the mentally ill zoomed from \$1 billion in 1963 to just over \$17 billion in 1985. Adjusted for inflation and for the number of patients, that's a fourfold increase. However mind-boggling, it did the truly mentally ill not a scintilla of good, for it bought them generally worse accommodations and much less psychiatric treatment than they had received from the asylums."

"The destruction the psychiatrists began, the civil liberties lawyers completed, sacrificing the mentally ill homeless on the altar of an idea of liberty and liberation exaggerated to the point of fanaticism and caricature."

This book will be very helpful in understanding today's sadly dysfunctional mental health system.

BITS AND PIECES

HIGHEST INCARCERATION RATE IN THE WORLD

After more than 50 years of stability, federal and state prison populations skyrocketed from under 200,000 persons in 1970 to more than 1.3 million in 2002. That year, our imprisonment rate rose above 600 inmates per 100,000 adults. With the inclusion of an additional 700,000 inmates in jail, we now incarcerate more than two million people — resulting in the highest incarceration number and rate in the world, five times that of Britain and 12 times that of Japan.

In 1937, women represented 48 percent of residents in state mental hospitals. In contrast, new prison admissions have consistently been 95 percent male. Also, the mental health patients from the 1930s to the 1960s were older and whiter than prison inmates of the 1990s.

Why did we diagnose deviance in such radically different ways over the course of the 20th century? Do we need to be imprisoning at such high rates, or were we right, 50 years ago, to hospitalize instead? Why were so many women hospitalized? Why have they been replaced by young black men? Have both prisons and mental hospitals included large numbers of unnecessarily incarcerated individuals?

Whatever the answers, the pendulum has swung too far — *possibly off its hinges.*

Editor's Note: *Below is a letter by a NAMI member that appeared in the Contra Costa Times Perspective Section (Page 4), Sunday, February 4, 2007.*

Dear Editor:

I was saddened to hear of the death of Derrick McCrary by drug overdose in the Contra Costa County jail. What concerns me is that the increasing number of people who have died while in custody would have been better served in the county mental health system.

Law enforcement must be better educated to spot obvious signs of mental crisis, such as the severe paranoia that was clearly displayed by McCrary. He should have gone to a psychiatric facility on a 5150 hold. Officers must distinguish when mental illness (substance induced or not) is the underlying cause and act appropriately. The recent news of a 17-year-old suffering from meth-induced psychosis shot while running away from police further (This letter continued in the next column)
