## **DYSFUNCTIONAL FAILURE**

### THE VIEW OF TWO TOP OFFICIALS IN THE SYSTEM

The Mental Health Commission toured the psychiatric facilities at the Contra Costa Regional Medical Center for the second time in two months.

A system that has always fought a battle to give an acceptable level of service to the mentally ill, has encountered major problems that have disastrously impaired the service.

Dr. Jeff Smith, the Director of the hospital, was very open and candid with the commissioners.

He explained that the current problems began with a suicide on the psych unit in 2004. The ensuing investigation into the incident resulted in the regulators insisting that the psychiatric emergency unit at the hospital should be under a different regulation than it was and forced a precipitous change from being a unit run as a part of the Out Patient system to one regarded as part of the hospital. From being covered by what is called Title 9 to being operated under Title 22.

To suddenly make such changes, virtually overnight has

thrown the hospital into turmoil.

The requirements under Title 22 call for more medical staffing, reflecting the needs of the clientele of the typical emergency room.

In recent years the Psychiatric Emergency Unit was under the jurisdiction of the Mental Health Division. It was, in effect, the emergency unit for the outpatient system. Mental Health Clinical Specialists were the backbone of the organization.

Virtually overnight that all changed. The major factor in the recent crisis is that the reorganization suddenly forced on the hospital was unexpected, unplanned for and almost impossible to allow for a smooth transition.

The result has been a catastrophic loss of highly trained personnel. Everyone interviewed, stated categorically that the crisis is acute and there doesn't appear to be much light at the end of the tunnel.

One would hope that the Board of Supervisors is following this problem very closely.

## ANTIDEPRESSANTS MOOD STABILIZER STUDY

A large, well documented, placebo-controlled trial of outpatients with bipolar depression who were receiving mood stabilizers indicated that adjunctive antidepressant therapy did not reduce symptoms of depression, but did not increase the risk for mania. However, longer-term outcome studies are needed to fully assess the benefits and risks of antidepressant therapy for bipolar disorder.

## FDA APPROVES JANSSEN'S INVEGA

The U.S. Food and Drug Administration has approved INVEGA, an extended release tablet which is an atypical antipsychotic. It will be used for the long term maintenance treatment of schizophrenia. INVEGA is now indicated for both acute (short-term) and maintenance (long-term) treatment of schizophrenia.

The approval is based on a long term efficacy study that demonstrated a significant benefit in delaying the time to relapse of symptoms of schizophrenia. The study further supports the proven safety and tolerability profile seen in prior short-term studies. INVEGA is marketed in the U.S. by Janssen, L.P.

# \$544,000 GRANT TO NAMI ELI LILLY GIVES NAMI NATIONAL MAJOR GRANT

EDITOR'S NOTE: This article is based on the article by Avery Johnson in the Wall Street Journal.

Detractors of NAMI sometimes make an issue of the fact that NAMI National has received grants from time to time from pharmaceutical manufacturers. The thinking being that because of such a grant, NAMI parents would feel somehow compelled to recommend (push) medications to their loved ones.

The opposite is true. NAMI parents are much more likely to make an educated decision based on what they have learned in the Family to Family classes and the support groups. There they acquire information that enables them to make a considered decision as to what medications would be best or whether any medication is warranted.

The influence of a financial grant at the national level is non-existent to a caring NAMI parent.

Lilly gave grants of \$11.8 million in the first quarter of 2007 to various institutions throughout the county. NAMI National received about 4.6% of that amount.

\$450,000 of what NAMI received was used to fund a project called "Campaign for the Mind of America." None of the funds is passed on to local affiliates. Lilly said that there is no connection between its grants and efforts to market its drugs.

Lilly's best selling drug is Zyprexa.

Some NAMI-CC members have been receiving therapy at the Touchstone Center which is in Pleasant Hill at 140 Mayhew Avenue.

They have a variety of ways to pay including, Medi-Cal, Contra Costa Health Plan, Visa, MasterCard, CalWorks and Victims of Crime.

Touchstone has about eighteen licensed professionals and supervised interns offering counseling services. Among the services offered are those dealing with anger management and domestic violence.

Individual and group therapy services for perpetrators and victims are offered. There is a 19 week anger management class, a 52 week parenting class and a 52 week domestic violence batterer's treatment program as well as a gambling addiction program.

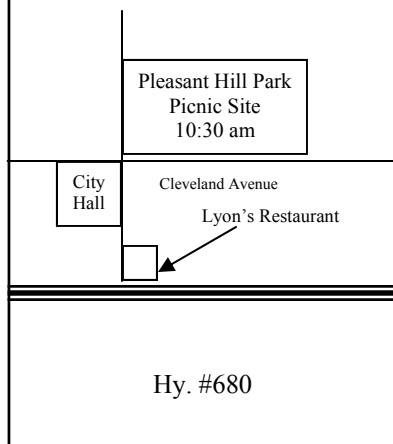

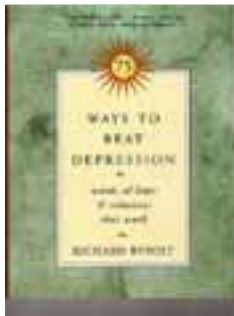

*75 Ways To Beat Depression*  
 Words of Hope and Solutions That Work. By Richard Rybolt, Published by Marlowe & Co., New York, 246 pages, \$13.95. Available at Borders and the NAMI-CC Library.



This compact book is a gem. Richard Rybolt offers a creative new approach to beating depression and dealing with the demoralizing effects that accompany this illness. It provides a wealth of valuable information and self-help tools in an easy-to-read journalistic style. After successfully learning to recognize, self-monitor and free himself from his own “battle of the blues,” Rybolt gives hope and help to others by illustrating through personal experience how it is possible to overcome depression and return to a happy, productive life. He demonstrates the importance of getting to the root of the problem, the very prerequisite for a new appreciation of life—a life free of fear, anxiety and shame. *Acquainted With The Night* is another good book on depression. The Mental Health Court is “open for business!” Its inaugural session was Monday, May 14, 2007. The Honorable Joni Hiramoto presided as she will every Monday.

The formation of the Court was made possible due to the Contra Costa County Sheriff’s Office receiving a \$1.5 million Mentally Ill Offender Crime Reduction Grant (MIOCRG) from the State Department of Corrections and Rehabilitation. The county was in competition with 39 other counties for the grant.

Dear Editor:

I have a lot on my plate right now besides my son. My father had a stroke last year and several smaller ones recently. He is not doing well. My brother, who is schizo-affective, was hospitalized (on 4-c) and conserved a year ago, has been doing well on the Consta injection, living independently, but has lost his medication coverage. My parents are paying \$1,800 out of their own pockets to buy his meds. My father is a retired school teacher, my mother is a retired secretary.

They had a very comfortable fixed income, but nothing that can handle an additional \$1,800 mo. My mother, who is a control freak, has had a complete melt down over all of this and has cut off everyone in the family, including me. My brother won't speak to me because I helped to get him into the hospital last year and testified against him in a conservatorship trial.

So, they won't let me help find a way to resolve the insurance problem. There is more, but I will spare you the details. The story of my family alone and its struggles with the mental health system could easily justify the declaration of a systemic crisis.
